## **END-USER LICENSE AGREEMENT FOR *Trams Scripts for Amadeus Users***

**IMPORTANT-READ CAREFULLY:** This Software License Agreement is a legal agreement between you (either an individual or a single entity) and Bill Shelley, developer of ***Trams Scripts for Amadeus Users*** software product identified above, which includes computer software and associated media and printed materials. By installing, copying, or otherwise using the SOFTWARE PRODUCT, you agree to be bound by the terms of this Software License Agreement.

### **SOFTWARE PRODUCT LICENSE**

The continuing annual subscription for the software is \$150 per year per main pseudo city plus \$25 per additional pseudo city, which entitles you to free email support, phone support via a non-toll free number, as well as free updates via email anytime requested throughout the year. There is no additional charge for home users or outside agents, but no support is provided for them. Additionally, when a major change is made to **Trams Scripts for Amadeus Users** because of a change by Amadeus or Trams, you will automatically receive the updates without having to request them, but ONLY via email.
